My submission is that **Environment Canterbury should decline all the consents** sought by the Applicant – namely

CRC094168 – to dam water within the mainstem of the Hurunui River and Lake Sumner

CRC094169 – to discharge water into the mainstem of the Hurunui River immediately downstream of the weir

CRC094170 – to dam water within the South Branch of the Hurunui River

CRC094171 – to discharge water into the South Branch of the Hurunui River immediately downstream of the dam

CRC094347 – to take and use water for hydro power generation

CRC094172 – to divert, take and use up to 32 cubic metres of water per second from the mainstem of the Hurunui River

CRC094350 – to discharge water from the irrigation canal into another catchment

CRC094173 – to discharge water from the irrigation canal into the Hurunui River.

As an interim measure I submit that Environment Canterbury should defer any decision on the consents sought pending the finalisation and approval of the current Hurunui Water Conservation Order application.
